Office latest by **5<sup>th</sup> November, 2020.**

3. Domicile Certificate with on-line verification (Xerox) through <http://edistrict.up.nic.in/> OR <http://bor.up.nic.in/>
4. Last Year Result (Internet Downloaded copy)-- Not required for 1st Yr.
5. 12<sup>th</sup> Passing Certificate & Marks Sheet (Xerox)
6. 10<sup>th</sup> Passing Certificate & Marks Sheet (Xerox)
7. Pass Book of Local Bank Account (Showing A/c Holder Name, A/c No., Bank Name, Branch & IFS Code)(Xerox)
8. Receipt of deposited College & Hostel Fee (Xerox)
9. Identity Proof with Number (Xerox)
10. Adhar Card (Xerox)
11. Affidavit of Parent & Student (Original)
12. Gap Affidavit (Original)(if any)
13. Adhar Card of Parent, whose Income is mentioned in Scholarship Form. (Xerox)

**Note 1:** Students are advised to contact the Admin. Office before taking the **Final Printout** of scholarship form for any clarification.

**Note:2** Students are required to complete KYC of their Bank Account.

**Note:3.** Students are required to submit all the above said documents(in order) in **ONE** set (self attested).

**Note:4** Students are advised not to wait for the last date.

**Special Note:** As per the directions of UP Govt, if any student does not maintain minimum **75%** attendance in the class/assignment/practical work etc throughout the academic session, scholarship form of such students will not be forwarded to the District Social Welfare Deptt. and also any kind of scholarship amount may not be reimbursed.
